1 Inngangur

1. Fjarskiptastofu (FST) bárust uppfærð gögn frá markaðsaðilum fyrir fyrri hluta árs 2023 í október 2023. Tölur fyrir hvern landfræðilegan markað sem sýna fimm gagnapunkta frá lok júní 2021 til loka júní 2023, er að finna í köflum 2 og 3 hér að neðan. Framsetning gagna fyrir hvern markað er með sama hætti og í köflum 6.2 og 6.3 í markaðsgreiningu í viðauka A, tölurnar eru útskýrðar í kafla 6.2.1.

2. Þrátt fyrir að þessi gögn fyrir fyrri hluta ársins 2023 séu nú tiltæk ákvað FST að ráðast ekki í þá vinnu að uppfæra alla markaðsgreininguna með þessum gögnum. FST rannsakaði nýju gögnin fyrir hvern landfræðilegan markað til að sjá hvort þau kölluðu á breytingar á tilnefningu aðila með umtalsverðan markaðsstyrk. Niðurstaða þessarar rannsóknar var sú að ástæða væri til að breyta mati á umtalsverðum markaðsstyrk á þremur landfræðilegum mörkuðum, þ.e. í Súðavíkurbreppi á markaði 3a og 3b, Vopnafjarðarhreppi á markaði 3a og Fljótsdalshreppi á markaði 3b. Eftir ítarlega viðbótarrannsókn taldi FST hins vegar ekki gildar ástæður til að breyta mati í Seltjarnarnesbæ þrátt fyrir aukna markaðshlutdeild Ljósleiðarans í því sveitarfélagi. Þessar breytingar á niðurstöðu FST sem leiddi af nýju gögnunum fóru í innanlandssamráð, annað samráð FST í þessu máli. Í þriðja samráði FST breytti stofnunin afstöðu sinni til umtalsverðs markaðsstyrks Mílu í Rangárþingi eystra. Ástæða þeirrar breytingar voru upplýsingar sem komu fram í fyrsta samráði FST, sem kölluðu á frekari gagnaöflun og leiddi til leiðréttinga á gögnum í því sveitarfélagi.

3. FST hefur ekki nýrri upplýsingar um tengingar farsímanetsbeina en hefur bætt þeim tengingum við fastanettengingar fyrir lok júní 2023 á sama hátt og gert var fyrir fastnetstengingar í árslok 2022. Upplýsingar um farsíma netbeinatengingar voru frá apríl 2023 og þær upplýsingar eru því nær upplýsingum frá júní 2023 en desember 2022.

4. Þegar litið er á tölur um útbreiðslu á myndunum hér að neðan má benda á að hlutfall ljósleiðaraútbreiðslu getur minnkað á milli ára á landfræðilegum markaði. Þetta getur gerst þegar heimilum og fyrirtækjum fjölga og annaðhvort er ekki lagður ljósleiðari á-til þessara heimilisfanga eða að seinkun verður á skráningu ljósleiðarans. Þetta getur líka gerst þegar heimili eða fyrirtæki er ekki lengur skráð sem slíkt sem veldur fækkun heimila og fyrirtækja í ákveðnu sveitarfélagi og heimilið/fyrirtækið var með ljósleiðaratengingu.

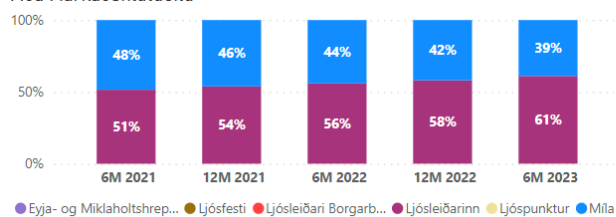
